On 4/13/65, GEORGE HOPKINS, Manager, Glen Towers Apartments, advised that ROSSELLI was around the apartment during the weekend and on Tuesday, 4/13/65, he observed ROSSELLI leave the apartment alone at about 10:30 a.m.; that on Sunday, 4/11/65, KATHY HORDEN, the girl who formerly lived with ROSSELLI came to the apartment and borrowed ROSSELLI's car and used it for part of the day; that HORDEN has come to the apartment on at least one other occasion during the past week or ten days and that on 4/13/65, a telephone message was left for ROSSELLI to call Mr. or Mrs. CROSLY (phonetic) at his convenience concerning an invitation to their home for dinner.

On 4/13/65, ROSSELLI's car was observed in the parking lot of the Gibraltar Square Building, corner of Wilshire Boulevard and Doheny Drive, Beverly Hills, Calif., at about 11:30 a.m. and as of about 3:30 p.m. the car was still parked in the lot. JAMES P. CANTILLON, Attorney, who is a friend of ROSSELLI, has offices in this building.

CSLA 4268-C observed ROSSELLI having dinner at Martoni's Restaurant in Hollywood, on the evening of 4/15/65. LINDSEY CROSBY, son of BING CROSBY the well known signer, and two young girls were with ROSSELLI.

On 4/16/65, GEORGE HOPKINS advised that a good looking woman about 26 years old, 5'6" or 7" tall, slim build, and long bleached blond hair has been staying with ROSSELLI for the past several days and on 4/15/65 she and ROSSELLI moved a lot of her clothes into ROSSELLI's apartment. HOPKINS will endeavor to obtain the name of this woman.

On 4/13/65, LA 4145-C advised that he had learned from FRANZ BREITLING, owner of Ajax West Coast Corporation, Santa Barbara, California, that ROSSELLI recently sold about 26 Kold Draft ice cube machines to some establishment in Las Vegas, Nevada, and has potential orders for about 100 additional machines within the next several months. ROSSELLI sells ice cube machines and Ajax West Coast Corp. sends the machines to the buyer, collects the money, and then sends ROSSELLI a check for his profit on the sale. In this connection, recent examination of ROSSELLI's bank account at the Fidelity Bank, Beverly Hills, California, revealed a deposit of a check for \$525.72 drawn on the Crocker-Anglo National Bank, Santa Barbara, California. In the past ROSSELLI has received check from the Ajax West Coast Corp. which were drawn on this bank and this check was probably a payment for ROSSELLI's profit on the sale of ice cube machines.
