Miami should be alert to fact that subject using name of Reyes has been in contact with the Cuban Embassy in Washington, D.C., and has furnished information that apparently refers to Diaz Lanz to Cuban officials. Close contact should be maintained with Diaz Lanz in order that you will be immediately aware of his decision in this matter. In addition, you should be alert to possibility that Randolpho Cossio, Cuban Air Attache, Miami, Florida, may take over the handling of subject in Miami and you should closely follow subject's activities until this matter is resolved. Keep Bureau advised of pertinent developments and submit all information developed in form suitable for dissemination.

NOTE: Pedro Luis Diaz Lanz, former chief of the Cuban Air Force, on 12-15-59 advised Miami that subject at the direction of Captain Angel Saavedra, Cuban Military Attache, Washington, D.C., had contacted him 12-14-59 for purpose of presenting a plan which called for Diaz Lanz and other anti-Castro leaders to accept and distribute Cuban counterfeit money with view toward destroying balance of Cuban economy. Diaz Lanz advised plan is trap by which it could be charged that U.S. had instigated plot to financially injure Cuba. According to Diaz Lanz, subject told
