By Form FD 376, dated 4-30-65, a copy of
Miami LHM dated 4-16-65, was furnished to Secret
Service, Miami, specifying subject JACKSON as an
individual falling within category six.

On 5-7-65, the information relating to
ISRAEL MESA, who resides at 3253 McDonald Street,
Miami, Florida, relative to his possession of a .45
caliber weapon and the possession, as of 4-12-65,
of a home-made bomb, was furnished to Officer
GEORGE STRINGER of the Miami Police Department and
to IRENE SCHUBOWSKI, secretary in the Intelligence
Division of the Dade County Sheriff's Office, Miami.

On 5-7-65, Customs Agent AL YARBROUGH,
Miami, Florida, advised that since receipt of information
from the Miami FBI office on 4-15-65, relative to
activities of subject JACKSON, he, YARBROUGH, has been
in regular contact with JACKSON, utilizing him as a
source with the purpose of developing evidence of
violation of the Neutrality Law on the part of ORLANDO
BOSCH and members of the latter's organization at Miami.

On 4-27-65, JACKSON reported that he had contacted ISRAEL MESA and made arrangements to meet MESA, ORLANDO BOSCH, and MARCELINO GARCIA on the night of Fig 4-27-65, at the offices of the MIRR (MOVIMIENTO INSURRECCIONAL REVOLUCIONARIO DE RECUPERACION), BOSCH's organization. On the night of 4-27-65, a surveillance was maintained in the vicinity of the MIRR office and while it was observed that JACKSON appeared at that office, no one showed up.

On 5-7-65, PSI FRANK RODRIGUEZ advised that EVERETT JACKSON has continued to maintain some contact with RAMON BAZ, 900 block of S. W. 31st Avenue, Miami, relative to a bombing mission to Cuba but BOSCH is not interested. ~~(u)~~

The PSI further advised that ORLANDO BOSCH of the MIRR has stated that he places no trust in JACKSON. RODRIGUEZ said it was not clear whether BOSCH's lack of trust in JACKSON related to JACKSON's capability for a raid or whether it pertained to a suspicion that JACKSON might have contact with authorities. ~~(u)~~

In view of the fact U. S. Customs is currently utilizing JACKSON in an informant capacity and thereby maintaining some control over his activities, no further action in this case is contemplated by the Miami Division.
