NEUTRALITY MATTERS**

On June 16, 1965, SJ ~~SA~~ T-1, a Cuban exile leader in Puerto Rico, who has furnished reliable information in the past, advised that EUGENIE LAFITTE, Puerto Rican delegate of the MIRR, had held a secret meeting on the evening of June 15, 1965, to decide their course of action in regards to the protest planned against the arrest of their leader, Dr. ORLANDO BOSCH, in Florida.

Source advised that instead of any demonstration at this time, the group planned to send a cablegram of protest to President JOHNSON asking for the release of this Cuban exile leader. The group planned no action at this time but wanted to await the outcome of the legal hearings in Florida.

This document contains neither recommendations nor conclusions of the FBI. It is the property of the FBI and is loaned to your agency; it and its contents are not to be distributed outside your agency.
