Re Legat, Ottawa letter to Bureau, dated 2/15/63, captioned "EDWARD J. MC GRATH, AR", transmitted to NY by routing slip dated 2/19/63, under the NOONAN caption.

For the information of the Philadelphia, Buffalo and Miami Offices, NY 3763-C*, an anonymous source having access to the office of CORNELIUS J. NOONAN, President, Local 1730, International Longshoremen's Association (ILA), Room 901, 265 West 14th Street, NYC, made available, among other items, the name of the following individual, who has apparently been in contact with NOONAN:

"CHARLOTTE MOYER
In care of MILDRED MAHONEY
Ridgeway, R.R. 2
Ontario, Canada"

(There is a notation that a personal money order, #0810334, in the amount of \$75.00, was obtained from the Bankers Trust Company, New York City, on 7/9/62, and was made payable to CHARLOTTE MOYER.)

Referenced Legat, Ottawa letter forwarded as an enclosure a letter from C. W. J. GOLDSMITH, Superintendent, Officer in Charge, Criminal Investigation Branch, Royal Canadian Mounted Police, reflecting the following information:

"Enquiries through Bertie Township Police Department, Ridgeway, Ontario revealed that Mildred MAHONEY, who resides on Victoria Avenue, R.R. #2, Ridgeway, is the wife of Walter J. MAHONEY, Attorney, Marine Trust Building, Buffalo, New York. It was also learned that Walter J. MAHONEY is a brother of William MAHONEY, State Senate Majority Leader, of the State of New York.

"Sgt. R. SHULTZ, Bertie Township Police, who is a close friend of the MAHONEYs, advised that Charlotte MOYER is a divorcee from Philadelphia who visited Mildred MAHONEY at Ridgeway during July, 1962, having met the MAHONEYs at a race track in Florida. According to SHULTZ, Mildred MAHONEY will be leaving for Florida within the next week and will not be returning to Canada until the summer of 1963. It is felt that Mildred MAHONEY would supply any information desired to your Bureau, however she was not interviewed due to the nature of this enquiry."

It is noted that WILLIAM MAHONEY is referred to as a State Senate Majority Leader of the State of New York. It is further noted that WALTER J. MAHONEY is the State Senate Majority Leader of the State of New York. Buffalo is requested to determine whether MILDRED MAHONEY is the wife of WALTER J. MAHONEY or WILLIAM MAHONEY.

For the information of all offices, it is pointed out that "a report was published recently in which WALTER J. MAHONEY, Majority Leader of the New York State Senate, charged that FBI Agents were honeycombing New York State at the direction of Attorney General ROBERT KENNEDY to gather information that could damage the Administration of Governor ROCKEFELLER."

The above appears in an article by JOHN WHEELER of the North American Newspaper Alliance. For this reason, discretion must be utilized by all offices to avoid causing embarrassment to the Bureau.

Buffalo is requested to determine the address of MILDRED MAHONEY in Florida. Miami, upon receipt of this information from Buffalo, is requested to interview MILDRED MAHONEY concerning CHARLOTTE MOYER. Philadelphia is requested, upon receipt of background information from Miami, to obtain all available information concerning MOYER, and furnish same to the NYO.
