9. Informant furnished the following information on dates indicated:

On 11/19/63 informant advised that an individual who is assigned to Central Investigation Bureau, NYCPD was an old friend of NOONAN and FUREY's and was discussing his work on HAROLD KOENIGSBERG, Newark Top Hoodlum. This individual revealed his undercover status to NOONAN and FUREY. Based upon the information furnished by the informant, the individual was identified. The CIB was discreetly advised of the substance of the information and the individual has been removed from CIB.

On 12/4/63, informant reported that TEDDY GLEASON discussed a five hour conference he had with JIMMY HOFFA, which was interrupted by the arrival of HARRY BRIDGES. GLEASON also discussed the fact that he thinks HOFFA is insane. GLEASON, NOONAN and FUREY discuss Christmas presents apparently being sought by them from the trucking companies.

On 12/13/63 NOONAN indicated that GLEASON is in need of money and that GLEASON wants NOONAN to collect some in an unspecified manner, which will put NOONAN in trouble.

On 12/16/63, NOONAN advised GLEASON that there is an individual "upstairs" (ILA Headquarters) "who is a very bad individual" and of whom NOONAN is afraid. This individual is demanding something and both NOONAN and GLEASON are reluctant to refuse him. No further information has been developed to date to identify this individual.

On 12/18/63, informant furnished information regarding two individuals who were fired from a trucking company for pilfering. This information has been furnished to 15-0 file since the matter in question is being considered for prosecution in the EDNY. The original information regarding this matter was furnished by PCI [REDACTED]. The information furnished by NY 3778-C* indicated that NOONAN and FUREY are aware that pilferage exists at this company, The Continental Trucking Company, Maspeth, Queens. This company is presently being struck by Local 1730, ILA, because these two individuals were fired.
