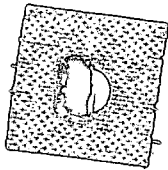

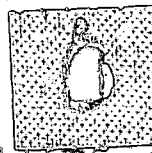

Rerep SA Harold Rubenstein 3/8/65 at WFO concerning Henri Clermont, and your letter 3/4/65 with enclosure concerning Movimiento Democrata Cristiano (MDC). (u) (u)

Rerep sets forth information received from Haitian Desk Officer, State Department, concerning visit of Haitian exiles and informant. Enclosure to 3/4/65 letter briefly alludes to information received from informant concerning this visit. (u) (u)

Bureau received no information from your office indicating informant planned to accompany Haitian exiles to Department of State. (u) (u)

This should have been done so that Bureau would have been in position to answer any inquiries which may have been referred on urgent basis to Bureau from Department of State. (u) (u)

Advise Bureau whether informant told your office of his plans to accompany Haitian exiles to Washington, D. C., before he actually made the trip. If he did not, furnish Bureau with remedial steps being taken by your office to rectify situations of this type in future. (u) (u)

You should also be certain, if an informant leaves your territory on missions of this nature, that the Bureau is promptly advised so that it will be in position to answer any inquiries which may be received concerning informant's activities. (u) (u)
