GABRIEL MANNARINO ANTI-RACKETEERING

Reference is made to report of Special Agent THOMAS G. FORSYTH, III, Pittsburgh, November 14, 1962.

There follows a brief characterization of informants used in referenced report.

PG T-3 is a professional man whose services have on occasion been used by members of the MANNARINO organization and who frequents MANNARINO controlled gambling and after-hours establishments.

PG T-4 is a businessman whose business activities bring him into occasional contact with members of the racketeering element in New Kensington, Pa.

PG T-24 is a life-long resident of New Kensington who has for many years held a low echelon position in the rackets.

PG T-27 is a New Kensington Businessman and minor politician with wide acquaintance in the racketeering element of the area.

PG T-39 is a Pittsburgh, Pa., gambler and club operator.
