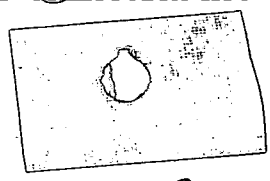

JOHN ROSELLI, AKA. AR.

LA FOUR TWO SIX EIGHT DASH C ADVISED THAT ON JULY THIRTY ONE LAST WHEN MAURICE H. FRIEDMAN MADE TELEPHONE CALL TO LOUIS LEDERER, FROM FRIAR-S CLUB ROSSELLI TOLD FRIEDMAN TO TELL QUOTE HIM UNQUOTE TO GET OUT HERE AND BRING THAT ATTORNEY.

INFORMANT ADVISED HE SAW ROSSELLI AT FRIAR-S CLUB, BEVERLY HILLS, CALIFORNIA, AT ABOUT FOUR FIFTEEN P. M. ON AUGUST ONE LAST. AT ABOUT SEVEN FIFTEEN P. M. ROSSELLI REMARKED HE WAS GOING TO TAKE STEAM BATH AND THEN GO HOME.

WHILE AT FRIAR-S CLUB ON AUGUST ONE LAST ROSSELLI WAS WITH MAURICE FRIEDMAN AND RALPH MARKS. MARKS TOLD INFORMANT HE LOST THREE OR FOUR HUNDRED DOLLARS.

ROSSELLI TOLD DALE ROBERTSON, TV ACTOR, NOT TO FORGET THEIR DATE ON AUGUST TWO INSTANT AT SEVEN P. M. AT PERINO-S RESTAURANT. FRIEDMAN THEN REEMPHASIZED PERINO ENGAGEMENT. ROBERTSON TOLD INFORMANT HE WAS CURRENTLY IN THE BUSINESS OF LENDING MONEY.
