On 8/11/64 Doctor [redacted] Central Bureau, Criminal Division, Italian National Police, Rome, Italy, advised that the stops against the subject continue in full force. (u)

OTHER

Concerning the confusion which arose over the identity of the individual who attempted to enter Italy on 7/31/64 by means of a falsified passport, Doctor [redacted] advised as follows:

The Italian police had exchanged communications with Canadian authorities concerning one ANGELO BRUNA, an Italian citizen who was being expelled from Canada for narcotics activity. The Canadian authorities advised the Italian police of the date and flight on which BRUNA would arrive in Italy. This information was furnished by the Central Bureau, Criminal Division, to the airport police in Milan, Italy. Airport police in Milan, however, mistakenly filed this information in the subject's file and so, when BRUNA arrived as scheduled and tried to use the falsified passport of ANTONIO SPOSITO, the airport police reached the erroneous conclusion that BRUNA was the subject. (u)

Doctor [redacted] stated that, as noted above, BRUNA is an Italian citizen and so far as is known has had no connections with the United States. (u)

Rome is continuing to maintain close contact with its sources concerning the projected travel of the subject to Italy. (u)
