

Attached for the Bureau is a letterhead memo treating of the CARDULLO-BROCCO fight of 8/2/64 and subsequent events involving ANGELO BRUNO, FRANK MONTE, FRANK IANNARELLA, and Pennsylvania State Representative HENRY CIANFRANI.

Confidential sources #1 and #2 utilized in this report are PH 614-C-TE. Two source numbers used in an effort to protect source's identity. Confidential source #3 is PH 672-C-TE, who claims to be a member of the Philadelphia family of La Cosa Nostra. Confidential source #1 and #2 is an intimate acquaintance of ANGELO BRUNO and numerous members of the Philadelphia family of La Cosa Nostra.

ANGELO BRUNO

On August 4, 1964, BASIL BROCCO advised Special Agents EDWARD D. HEGARTY and ROBERT W. HOLMES that under no circumstances would his brothers testify against IANNARELLA or MONTE because when the trial was over gunmen would be brought into Philadelphia from "out of town" and would retaliate against the BROCCO family.

The following information is set out concerning FRANK IANNARELLA, FRANK MONTE, and members of the BROCCO family:

~~FRANK IANNARELLA~~ AKA "SMUFFY" resides at 812 South Seventh Street, Philadelphia, PA has Philadelphia Police Department (PH PD) #256714 and FBI #679906D. IANNARELLA, according to Confidential Source #1 and Confidential Source #2 plays an essential role in the successful operation of ANGELO BRUNO's numbers lottery in the South Philadelphia area.

Confidential source #3 has advised that IANNARELLA will in the near future be "made" a member of La Cosa Nostra.

~~FRANK MONTE~~, 722 Warnock Street, Philadelphia, PA has PH PD #256868 and FBI # 629268E. MONTE has been identified by Confidential source #3 as a "soldato" in the Philadelphia family of La Cosa Nostra. MONTE is active on a daily basis in the operation of ANGELO BRUNO's numbers lottery.

PASQUALE BROCCO, SR., 619 Clymer Street, has PH PD #112577 and FBI #99335. He is 68 years of age.

~~ANTHONY BROCCO~~, 2746 South Sheridan Street, Philadelphia, PA was born 7/11/16 and has PH PD #156431 and FBI #2070616. PA

~~NICHOLAS BROCCO~~ resides at 769 South Sixth Street, Philadelphia, PA He was born February 7, 1923, and has Philadelphia Police Department #237949 and FBI #617857B.
