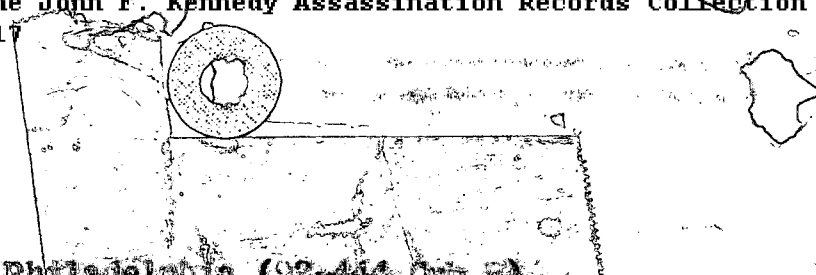

The first such airtel should be submitted by 10/16/64. Submit your recommendations regarding continuance beyond the authorized period to reach the Bureau five days prior to the expiration of this authority.

NOTE: Evans to Belmont memo captioned as above, dated 9/17/64, authorized the Philadelphia Office to install a concealed automobile transmitter (CAT) unit in the vehicle frequently used by Bruno. Philadelphia Office reports mike installed 10/2/64. Bruno is a "commission" member and leader of La Cosa Nostra in the Philadelphia area.

15. Remarks:

BRUNO's position as member of La Cosa Nostra and fact that he is in contact with other Commission members is known to the Bureau. It is possible that in the past when he borrowed informant's car it was to make these extremely important meetings. The "CAT" unit operates on Channel 2, which is common to surrounding offices and can possibly assist offices in coverage of BRUNO.
