Although the photograph of the Subject is not a recent photograph, informants have advised that the photograph is an excellent likeness of the Subject.

Subject's case has been re-evaluated in light of current criteria for SI subjects and it is believed that he continues to meet the standards and his retention as an SI subject is recommended.

An interview of the Subject at the present time is not deemed advisable in view of Subject's recent participation in the CP Convention and a "Left Wing Seminar" at the CLS.

Subject's residence was verified by pretext on February 26, 1957, by means of a telephone call to Subject placed by SA WILBERT H. KEHE.
