1. DURING THE WEEK OF 1 NOVEMBER 1976 RETIRED GENERAL RAUL  
~~GIMENEZ GAINZA~~, HEAD OF THE DIRECTORATE FOR THE SERVICES OF

INTELLIGENCE AND PREVENTION (DISIP), SAID THAT HE HAD ACCEPTED AN  
OFFER BY THE CUBAN GOVERNMENT TO PROVIDE HIM WITH EVIDENCE AGAINST THE  
FOUR INDIVIDUALS CURRENTLY UNDER DETENTION IN VENEZUELA IN THE CASE  
OF THE 6 OCTOBER CRASH OF A CUBANA AIRLINER. THE CUBAN OFFER,  
GIMENEZ SAID, CAME FROM NORBERTO ~~HERNANDEZ~~ CURBELO, THE  
CUBAN AMBASSADOR TO VENEZUELA.

2. THE EVIDENCE, GIMENEZ SAID, CONSISTS OF MEDICAL REPORTS WHICH  
THE CUBANS HAVE INFORMED HIM CLEARLY INDICATE THAT THE CUBANA CRASH

WAS CAUSED BY A POWERFUL BOMB. THE BODIES OF THE CRASH VICTIMS WERE EXAMINED BY DOCTORS FROM BARBADOS AND ANOTHER UNIDENTIFIED COUNTRY, AND CUBAN DOCTORS WERE IN NO WAY INVOLVED WITH THE EXAMINATIONS OR THE PREPARATION OF THE MEDICAL REPORTS. GIMENEZ SAID THAT HERNANDEZ INFORMED HIM THAT THEY SHOW THAT AN EXPLOSION DEFINITELY OCCURRED IN THE AIRCRAFT, AS MANY OF THE BODIES OF THE CRASH VICTIMS WERE BLOWN APART AT THE WAIST.

3. THE VENEZUELAN GOVERNMENT, GIMENEZ SAID, BADLY NEEDS ADMISSIBLE EVIDENCE AGAINST THE FOUR DETAINEES, AS LITTLE SUCH EVIDENCE CURRENTLY EXISTS. IN THE EVENT THAT THIS LACK OF EVIDENCE PERSISTS, GIMENEZ SAID THAT IT WAS POSSIBLE THAT THE CASE WOULD BE TURNED OVER TO THE MILITARY COURT WHERE MUCH LESS EVIDENCE IS NEEDED FOR CONVICTION.

4. ~~[[FIELD]~~ COMMENT: A USUALLY RELIABLE SOURCE INDEPENDENTLY REPORTED THAT TWO DISIP OFFICERS ARE TO BE DISPATCHED TO HAVANA ON THE MORNING OF 11 NOVEMBER TO PICK UP THE EVIDENCE OFFERED GIMENEZ BY THE CUBAN GOVERNMENT. A SOURCE OF UNDETERMINED RELIABILITY INDEPENDENTLY REPORTED THAT AS OF EARLY NOVEMBER THE VENEZUELAN GOVERNMENT LACKED ADMISSIBLE EVIDENCE AGAINST THOSE SUSPECTED OF BEING INVOLVED IN THE CUBANA INCIDENT, BEFORE VENEZUELAN COURTS
