TO TALK TO DR. BOSCH. SARDUY WILL BE TAKING WITH HIM \$5,000 TO GIVE TO BOSCH FOR LEGAL AND PERSONAL EXPENSES IN VENEZUELA. SOURCE ADVISES MONEY WAS PROVIDED BY DR. MODESTO MORA, JOAQUIN FONTANA, DR. MARTINIANO L. ORTA, DR. LUIS FERNANDEZ CONDE, AND DR. (FIRST NAME UNKNOWN) CAMPO, PRESIDENT, COLEGIO MEDICO INDEPENDIENTE (PRESIDENT OF COLLEGE OF INDEPENDENT MEDICS). ~~(u)~~

SOURCE FURTHER ADVISES THAT THERE APPEARED TO BE A QUARREL BETWEEN FOLLOWERS OF DR. BOSCH AND THE ABOVE MENTIONED MEDICS AS TO WHERE THE MONEY SHOULD BE SENT. ONE GROUP FAVORS THE MONEY TO GO TO GASPAR JIMENEZ AND ORESTES RUIZ WHO ARE PRESENTLY INCARCERATED IN MEXICO FOR ATTEMPTING TO KIDNAP THE CUBAN CONSUL, MERIDA, MEXICO. THE OTHER GROUP FAVORS THE MONEY SHOULD GO TO PAY FOR DR. BOSCH'S LEGAL EXPENSES. ~~(u)~~
