The source referred to in the enclosed memo is Baltimore informant 1154-C. He has requested that his identity not be disclosed.

Inasmuch as the Bureau has been furnished all information in this case, and inasmuch as the facts do not constitute a violation within our jurisdiction, no report is being submitted by the Baltimore Division UACB and this matter is being closed in the Baltimore Office.
