Please refer to your 14218 dated 2nd April, 1963, headed Roy Emory Hargraves and Rolando Masferrer Rojas.

With reference to your paragraph five, as far as is known to the authorities in the Bahamas, the only way in which the false statements were used was in the original press and television interviews given by WASHMANN in Miami on 11th March, 1963. They were certainly referred to in these interviews, but whether or not they were physically produced is not known.

With reference to your final paragraph, the authorities in the Bahamas are unable to help on the identities of the persons said to have returned to Florida with HARGRAVES. However, a report from the Bahamas states that one of the three U.S. citizens apprehended at Norman's Cay on 30th March, 1963, made a vague reference to the fact that the boat in which HARGRAVES sailed for Cuba was 'similarly armed' to that in which he was arrested by the U.S. Customs in December, 1962.

Apart from the above, it is regretted that nothing of security interest has been discovered from the counter-Cuban counter-revolutionary operations in which the Bahamas authorities have been involved.
