Re Miami letter to Director 3/10/64, captioned above, and NYlet to Director dated 3/31/64.

EMILIO BARQUIN DESVERNINE, 630 3rd Avenue, NYC, who is a PSI under development by the NYO and a member of the JURE in NY, on 4/6/64, advised that through a contact in the Cuban Catholic Welfare Center in NY, he learned that there was a MARIA ELENA de CARDENAS in NY who was alleged to be the daughter of a well known Cuban doctor named CARDENAS PUPO.

BARQUIN advised that he did not know this woman personally, but would determine whether or not she was active for the JURE in NY.

EMILIO BARQUIN on 4/8/64, advised that he further determined that MARIA ELENA de CARDENAS of whom he spoke was the daughter of a well known doctor still in Havana, Cuba, by the name of Dr. CARDENAS PUPO. BARQUIN said that MARIA ELENA de CARDENAS was a graduate of Vassar College, Poughkeepsie, NY, and apparently was working somewhere in NYC in a laboratory and also was doing extra work making translations. BARQUIN said that MARIA ELENA de CARDENAS allegedly has been in the US for 3 years and is currently residing at 306 East 96th Street, telephone number SA 2-6680.
