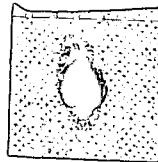
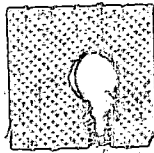

Reference is made to previous information furnished concerning the captioned anti-Castro organization.

For your confidential information, the Central Intelligence Agency (CIA) on December 6, 1963, advised that it was furnishing some financial assistance to the captioned organization because there were indications that it has some potential for infiltrating agents into Cuba. CIA further advised that it was maintaining limited liaison with Manolo Ray who heads the captioned group (S) (X) (U)

On January 23, 1964, a source in Puerto Rico, with whom insufficient contact has been had to determine his reliability, advised he had learned from one of his employees that Ray was planning an expedition to Cuba which would occur sometime in the immediate future and which would depart from Ponce, Puerto Rico.

Another source, a Cuban exile also residing in Puerto Rico, advised on January 24, 1964, that he had learned from one of his employees who is a member of the captioned organization that the employee's nephew, Nelsy Ignacio Castro, who is also a member of the captioned group, plans to depart Puerto Rico prior to February 15, 1964, to infiltrate Cuba to fight Castro. Reportedly, Castro is receiving some type of training in Puerto Rico in connection with his planned trip to Cuba.

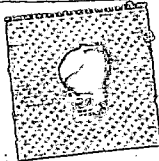

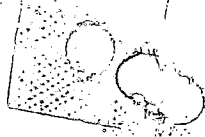
