ReMiami let to Director, dated 3/10/64, captioned as above.

Dr. RAUL CHIBAS, Representative of the JURE in NYC, on 3/25/64, stated that he was not personally acquainted with any woman in the NY area by the name of MARIA ELENA de CARDENAS. CHIBAS said that he was not too well acquainted with all the members of the NY Delegation of the JURE and suggested that ANGEL FIGUEREDO, a delegate of the JURE, be contacted concerning this matter.

ANGEL FIGUEREDO, a delegate of the JURE, on March 26, 1964, stated that the NY Delegation did not maintain records of membership. FIGUEREDO advised that he was not personally acquainted with an individual in the NY Delegation of the JURE by the name of MARIA ELENA de CARDENAS. FIGUEREDO advised that all information regarding membership is maintained by the Headquarters located in Miami, Florida. FIGUEREDO advised that inquiry concerning membership in the JURE can be made through Mr. OSORIO.

Miami is requested to contact Mr. OSORIO at the Headquarters of the JURE in Miami, Florida, and determine whether or not MARIA ELENA de CARDENAS is listed as a member of the NY Delegation. In the event such information is obtained and additional investigation is desired, the NYO should be requested to conduct further inquiry concerning the identity of this individual.
