STASIAK said that he was of the opinion that NELSON was considered one of JOHN LA ROCCA's boys since he and MIKE GENOVESE are in the car wash business together. On February 19, 1958, T-3, who requested his identity remain confidential and who stated he will not testify at any future Federal or State proceedings, advised that he is closely associated with JOHN LA ROCCA and MIKE GENOVESE and is familiar with many of the individuals who hang around the Red Eagle Club formerly called the Genovese Cocktail Lounge, 412 Larimer Avenue, Pittsburgh. T-3 said that ARTHUR NELSON has patronized the Red Eagle Club and is a close associate of MIKE GENOVESE; however, he has never been permitted to attend meetings of the "top men" in the Pittsburgh rackets when these men meetaat the cocktail lounge.

On March 11, 1958, Lieutenant JOHN JAMES, Pittsburgh Police Department, advised that he is personally acquainted with ARTHUR NELSON and from personal knowledge stated that NELSON desired to get out of the rackets and become completely legitimate because he has a son who he wishes to help become a doctor. Lieutenant JAMES said that NELSON wanted to get out of the numbers business and become disassociated from those who operate this type of business. NELSON desires to devote his time to the motel business and had progressed to the extent whereby he had blueprints of a motel which he planned to operate on Route 22 near Monroeville, Pa. pointed out that NELSON claimed he needed approximately \$87,000 to start on his motel enterprise and that the only available source for this amount of money was some of his associates who were numbers writers and racketeers in thet East Liberty section of Pittsburgh.

A check of long distance telephone calls made from Archie's Automatic Car Wash, 8050 Bennett Street, Pittsburgh, and from NELSON's residence, 1706 Georgetown Place, Churchill, Pa., revealed that contact had been had with the Hune, Incorporated, West Eighth Street, East Liverpool, Ohio. The Cleveland Division advised on February 21, 1958, that this company is operated by ROBERT MC DANIEL, Vice-President, and THAYER MC DANIEL, President. Hune, Incorporated is a business of THAYER MC DANIEL in which MC DANIEL controls all the juke box and pinball machines in the East Liverpool, Ohio area.
