INFORMATION CONCERNING

Re Newark airtels to Bureau dated 10/23/61 and 10/24/61, eos Philadelphia.

Re airtels pertained to information as developed by NY-2251-C* 10/17/61 in which the names of several individuals are mentioned, including the name of Philadelphia subject ANGELO BRUNO. Mention also was made of interest held by certain racket figures in joining Masonic orders. The names mentioned, according to information furnished by NY-2251-C* with the exception of ANGELO BRUNO are generally not familiar with the Criminal Intelligence Program investigations in the Philadelphia Division and appear to be figures from the New Jersey-New York City areas.

The only information in regard to the "Masons" as developed by the Philadelphia Division was recently obtained from PH-614-PC. This source in explaining the family make-up of the MICHAEL MAGGIO (deceased) family mentioned that the only MAGGIO that was not Catholic was MICHAEL MAGGIO's brother, GUS MAGGIO from Pittsburgh, Pa., area, who was identified as a Mason. The MAGGIO family's relationship with BRUNO is established by the fact that BRUNO's sister is married to PETER MAGGIO, one of the late MICHAEL MAGGIO's sons.

Regarding FRANKIE SALERNO, the Philadelphia Division has developed information through PH-523-C indicating that this person may be identical to a relative of Newark subject ANTONIO CAPANIGRO, aka TONY BANNAS. This informant, even though well acquainted with SALERNO, has not on prior occasions furnished any information showing SALERNO as being in the Masons as was developed by Newark source.

It is pointed out that original information showing ANGELO BRUNO was associated with the "Commission" was furnished verbatim to both the Newark and New York Offices and may contain the explanation as to the comment attributed to the informant when ANGELO BRUNO was referred to as a "kid" and as having been made the boss. Considering that the information received by the informant was from individuals apparently at least older than BRUNO, the explanation for this comment might well be the fact that it was established that BRUNO then being elevated to his present position in the "Commission" replaced Philadelphia subject ANTONIO POLLINA, aka, who is approximately 68 years of age, while BRUNO is in his early 30s. This reasoning would generally coincide with the tone of the entire conversation as developed by this source in that there is generally a complaint as to the method of currently handling the racket situation whereas the method of handling in the past was considered better.
