SD 1064-C-TE was re-contacted by SAS EDWARD MARI and JOHN D. ARMSTRONG and furnished the following information on La Cosa Nostra (LCN) on 3/9/67:

I. LOS ANGELES FAMILY

Informant advised that to his knowledge the last full membership meeting of the Los Angeles Family was in 1956. He continued to criticize the leadership of the Los Angeles Family, stating that the Boss, FRANK DESIMONE, and the Underboss, NICK LICATA, were afraid to do anything and that the Los Angeles Family had "very little going for it" in racket activity.

He stated that as a result of the publicity recently in the newspapers concerning a "crack down" on organized crime, that the leadership is now even more conservative than ever
