Background information on the subject was furnished in Spanish in writing together with copies of fingerprints and photograph to the Mexico City Metropolitan Police, the Judicial Police of the Federal District, Federal Judicial Police and the Mexican Immigration Service. These agencies are to notify Legat, Mexico City if they receive any information concerning subject. It was pointed out that he has frequently traveled in Mexico in the past and previously deported from Mexico.

In addition, [Mexico City informants MEX 42, MEX 196, MEX 258 and MEX 170], all of whom were acquainted with subject through his past travels in Mexico, were alerted to the possible presence of subject in Mexico.

[MEX 42 and MEX 196] during 7/70 attempted to locate subject in Acapulco, Mexico, with negative results.

On 8/3/70 [MEX 34] who has furnished reliable information in the past, advised that he conducted inquiry in Zihuatanejo, Guerrero, Mexico, where subject was known to have stayed in the fall of 1965.

He contacted personnel at the Hotel Zafari who remembered subject very well from his previous visit. At that time subject was with a group of about 12 people who occupied various rooms in the hotel. They had a helicopter, a late model automobile and a mobile home. They were also seen with submachine guns. Subject used the name EUGENE ROBINSON and ran up a bill of 50,000 pesos (\$4,000).
