On 9/24/64 Mr. WALLACE SHANLEY, Customs, Miami, and Lt. AARON ROGERS, Coast Guard Intelligence, Miami, MM T-1 and MM T-4, respectively, in myairtel 9/17/64, advised they had no objection to the info furnished by them being disseminated to the Spanish Govt., provided their identities were concealed (c)

ReBuairtel 9/23/64 with enclosed memo from Coordinator of Cuban Affairs, State Dept., mentioned that MANUEL RAY RIVERO probably was in San Juan, and set out lead for San Juan to interview RAY. (u) DECLASS PER DOS ON 1-6-98

Possibility exists RAY is in Miami and since he was reported to have been here on 9/21/64, in the event he is located in Miami he will be interviewed and results submitted along with other interviews conducted on 9/25/64. (u)

Indications are that FERNANDO COSTA of the Antonio Maceo Battalion is presently in Europe and unavailable for interview. This matter will be resolved through interview with LEONEL FRESNEDO URQUIZA. [It is noted the letter of the Cuban Coordinator indicated FRESNEDO was affiliated with LPN (The New Pines). He is actually the head of the Antonio Maceo Battalion and in no way connected with LPN. (u) DECLASS PER DOS ON 1-6-98

Inasmuch as MANUEL OSBO SAUSA, head of the ARSD, advised that HECTOR E. PONCE is no longer connected with the ARSD and is residing in Iowa, it is not believed investigation to locate and interview PONCE is warranted. (u)
