FOR information, CG 10920-PSI, who has furnished reliable information in the past, advised that MANOLO REYES, a Miami Cuban personality, was scheduled to speak before a group from Chicago's different exile organization on June 1, 1974. Source learned, however, that REYES received both a letter and a telephone call from Chicago stating in effect that if REYES travelled to Chicago he would be killed. As a result, REYES did not come to Chicago. *X (u)*

Source was unable to ascertain the individual or individuals responsible for the call and letter and refused to speculate if the "zero" organization was responsible. *X (u)*

Source felt that the letter and call were reflective of a new militancy amongst some exile groups and was a warning to those who had enriched themselves at the expense of other Cubans in the name of a free Cuba would not be tolerated. *X (u)*
