A MR. FRIEDMAN, AND A. MILLER DEPARTED LOS ANGELES SIX FIFTY FIVE AM AAL FLIGHT SEVENTY EN ROUTE PHONIX. TICKETS PURCHASED WITH CASH AT AIRPORT. NO RECORD THIS FLIGHT FOR GINA STEPHENS.

ROSSELLI IS SUBJECT INTENSIFIED INVESTIGATION, LOS ANGELES ORIGIN. HE IS SIXTY YEARS, FIVE FEET NINE INCHES, ONE HUNDRED SEVENTY POUNDS, WHITE HAIR, MEDIUM BUILD, AND DRESSES WELL IN EXPENSIVE CLOTHES. FRIEDMAN IS PART OWNER HOTEL LAST FRONTIER CORPORATION, LAS VEGAS, NEVADA. HE IS FORTY TO FORTY FIVE YEARS, FIVEFEET EIGHT INCHES, ONE HUNDRED NINETY POUNDS, RED ROUND FACE, HEAVY BUILD, BROWN HAIR.
