LA 4268-C furnished the following information re ROSSELLI's activities during the previous week:

On 12/9/63, came to the Friar's Club in Beverly Hills, California, at about 4:15 PM. ROSSELLI was alone. He talked to IRVING LEFF and several other persons at the club and then played cards. ROSSELLI was still at the club at 6:00 PM, when informant left.

On 12/10/63, informant observed ROSSELLI and MAURICE H. FRIEDMAN at the Friar's Club at 3:45 PM, when informant arrived. ROSSELLI was dressed in suit and was wearing a necktie, and left the club alone at about 4:00 PM, after talking to FRIEDMAN.

On 12/12/63, informant observed ROSSELLI at the Friar's Club from about 3:45 PM until 5:35 PM, at which time ROSSELLI went to the steam room in the club. Prior to going to the steam room, he was observed in conversation with BEN TEITELBAUM.

On 12/13/63, informant observed ROSSELLI and MORRIE SUESS, a motion picture producer and director, leaving the Friar's Club at about 3:30 PM. Both men were dressed in suits and were wearing neckties.
