The Las Vegas Office advised on 1/9/64, that ROSELLI checked out of the Desert Inn Hotel in Las Vegas on 1/5/64, and his present location was not known.

Spot checks were made during the current week of ROSELLI's residence in Los Angeles and of places in Beverly Hills, California, which he normally visits, but neither he nor his car was observed. No information was received from sources that he was in Los Angeles.

On 1/10/64, LV 129-PC advised that ROSELLI checked into the Desert Inn Hotel, Las Vegas, Nevada, at approximately 10:00 PM on 1/9/64.
