On 1/28/64, LV 129 PC furnished information that ROSELLI checked out of the Desert Inn Hotel, Las Vegas, on 1/27/64. ROSELLI's car has been observed at his Los Angeles apartment during the past week. On 1/30/64, fisur disclosed that ROSELLI left his apartment shortly after ten AM and proceeded to Beverly Hills, California. He made a short stop at an unknown point in Beverly Hills then spent about one hour at Drucker's Barber Shop and at about noon went to the Friar's Club.

On 1/29/64, the Las Vegas Office advised that VICTORIA LOCKWOOD, aka Natalie Vicki Loughran, Natalie Vicki Rosenstein (one of ROSELLI's girlfriends) obtained a work permit card in Las Vegas on 3/20/61, and has appeared as a dancer at the Flamingo Hotel and the Desert Inn Hotel. As of 12/22/63, she listed her address as 3501 Maryland Parkway, Las Vegas, Nevada, where she occupies apartment 72, and has telephone number 735-6837.

On 1/31/64, GERALDINE LOWELL, nee Riccio, advised that she is the sister of TONY RICCIO, who is a part owner of Martoni's Italian Restaurant, 1523 Cahuenga Boulevard, Los Angeles; that she formerly work ed part time as a hostess at this restaurant and met ROSELLI several years ago when he
