JEAN SOUETRE, AKA MICHEL ROUX, MICHEL MERTZ, INFO CONCERNING.

DIRECTION DE LA SURVEILLANCE DU TERRITOIRE (DST) FRENCH DOMESTIC COUNTERESPIONAGE SERVICE, ADVISES IT HAS RECEIVED INFO THAT A FRENCH NATIONAL USING NAME OF MICHEL ROUX OR MERTZ WAS EXPELLED FROM U.S. AT FORT WORTH OR DALLAS 48 HOURS FOLLOWING ASSASSINATION OF PRESIDENT AND THAT HE DEPARTED FOR MEXICO OR CANADA VIA HOUSTON. HE WAS ALLEGEDLY IN FORT WORTH THE MORNING OF NOVEMBER 22 AND DALLAS AFTERNOON SAME DAY. (C)

IN JANUARY 1963 HE RECEIVED MAIL FROM ONE ALDERSON, DENTIST, 5803 BURLINGHAM, HOUSTON 35. MICHEL ROUX BELIEVED IDENTICAL WITH JEAN SOUETRE WHO IS CAPTAIN, DESERTER FROM FRENCH ARMY AND ACTIVIST OF SECRET ARMY ORGANIZATION (OAS), ANTI DE GAULLE TERRORIST GROUP. (C)

IN VIEW COMING VISIT DE GAULLE TO MEXICO AND TERRORIST NATURE OAS FRENCH REQUEST DETAILS REGARDING ACTIVITIES, REASONS FOR EXPULSION, DESTINATION IF AVAILABLE AND CONTACT WITH ALDERSON FOR ANY INFO AVAILABLE. PLEASE SUCAB (C)
