It is noted that the Chicago source used, CG 6259-C, is very close to Mrs. PORTILLA, a member of ROSSEN's party and therefore, Chicago is expected to have some coverage, at least with respect to the party's itinerary. (M) (S)

The letterhead memorandum is being classified confidential because of the close relationship between CG 6259-C and Mrs. PORTILLA and because the information reported could compromise this source which could have an adverse effect on our national security. (S/M)

Chicago will report the return of both subjects to Chicago.
