Indices of the Richmond Office contain no record for PEDRO ENTENZA.

RH 161-S, who is familiar with CP members and activity in the State of Virginia, was contacted on 5/21/64, and related that the name of PEDRO ENTENZA is unknown to him, and he has no information concerning him.

Records of the Fairfax County Police Department were reviewed on 6/2/64, and no record located for ENTENZA.

Records of the Credit Bureau, Inc., were reviewed on 6/3/64, and no record located for ENTENZA.

On 7/2/64, JAMES GOODING, Deputy Clerk, Fairfax County Court House, Fairfax, Va., advised SA SAMUEL W. WEST that he is slightly acquainted with ENTENZA through their respective employments. GOODING said that he has never heard ENTENZA make any pro-Castro statements, and has heard from other unrecalled mutual acquaintances that ENTENZA is very much opposed to the Castro Regime. According to GOODING, ENTENZA is employed by the law firm of Jesse, Phillips, Kendrick and Geaheart, who have offices at 104 South Payne Street, Fairfax, Va. According to GOODING, this is a well known and respected law firm and their main offices are located at 1427 North Court House Road, Arlington, Va.

On 7/2/64, Sgt. CHARLES BAESGEN, Detective Bureau, Fairfax County Police Department, advised that no information had come to his attention reflecting any pro-Castro sympathy on the part of PEDRO ENTENZA.

The Richmond Office has no Cuban informants or sources in the Fairfax County area; it being noted that most of the activity among Cubans in the metropolitan area takes place in Washington, D.C. Richmond agrees with observations of the Miami Office as set forth in referenced Miami letter, that based on information developed to date, no investigation of ENTENZA is warranted.

In view of the above, no letterhead memorandum is being submitted at this time, and no further action is being taken by Richmond until results of a search of the indices and contact with Cuban sources by WFO is known.
