NY 5042-C-TE advised that the blackjack game operated by TOM GRECO (NY 92-1270) and JOE LEFTY, both members of the GENOVESE "family", had reopened at 95 2nd Avenue, NYC. NY 6031-C-TE and NY 5826-PC advised that a blackjack game was in operation at 37 W. 72nd St., NYC, Penthouse Apt. B.

Informants knew of no interstate aspect to the above games.

The above information was furnished to Inspector ED DONNELLY, NYCPD, on 7/31/68. Inspector DONNELLY advised on 8/6/68 that based on the above information, 8 persons were arrested for gambling at 37 W. 72nd St., on 8/2/68, and 7 persons were arrested at 95 2nd Ave. One person was charged with operating and maintaining a gambling establishment and 6 persons were charged with gambling.

Inspector DONNELLY stated the game at 95 2nd Ave. was doing approximately \$25,000 a week business and the game at 37 W. 72nd St. was doing approximately \$15,000 a week business. Inspector DONNELLY expressed his appreciation for the cooperation of the NYO in furnishing the above information.
