Subject, on 1/21/58, was in telephonic contact with Dominican Republic Ambassador at Washington, D. C., asking if that Government had reached a decision concerning his working for Dominican Government on a year-round basis. Subject was informed the DR Government would advise him when a decision had been reached.

A mail cover is believed necessary to develop information of value to this investigation which is not available from any other source. It is believed that a mail cover will be productive. There appears no possibility of embarrassment to the Bureau from maintaining such a mail cover.
