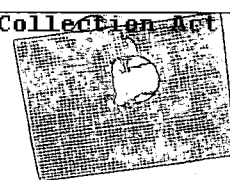

SAMUEL M. GIANCANA, AKA, AR. DAILY SUMMARY. MART MURRAY, BROTHER OF PCI GERARD QUOTE HAT END QUOTE MURRAY, MENTIONED PREVIOUSLY AS HAVING BEEN BEATEN BY UNKNOWN HOODLUMS IN OBVIOUS ATTEMPT AT FORCED RETIREMENT FROM BOOKMAKING, ADVISED APRIL TWENTYFOUR LAST THAT GERARD MURRAY HAS TAKEN QUOTE TRIP END QUOTE OUT OF CHICAGO, AND UPON HIS RETURN, WILL RETIRE FROM BOOKMAKING ACTIVITIES, CONTEMPLATES JOINING HIM IN CONSTRUCTION BUSINESS BUILDING RESIDENTIAL HOMES. GERARD MURRAY STILL HAS NOT ASCERTAINED IDENTITY OF HIS ASSAILANTS. MART MURRAY BELIEVES MURRAY/S QUOTE RETIREMENT END QUOTE WAS FINALLY PRECIPITATED BY FACT THAT TWO WEEKS AGO, THREE OF MURRAY/S BOOK-MAKING OPERATIONS IN FORTY FIFTH WARD, CHICAGO, WERE RAIDED BY THE GAMBLING DETAIL, CHICAGO PD, WHILE THE OPERATIONS OF KNOWN SYNDICATE MOBSTERS WERE LEFT UNTOUCHED. CG SIX FOUR FIVE SEVEN DASH PC ADVISED APRIL TWENTY FOUR LAST THAT SHE HAS MANAGED TO GAIN SOME CONFIDENCE OF ROCCO PRANNO, KNOWN TO HER AS JIM MARTEL, COMMONLY KNOWN ALIAS OF PRANNO. PRANNO, A LIEUTENANT OF GIANCANA IS OPERATOR OF KEY LOUNGE, PRIVATE CLUB, STONE PARK, ILL. PRANNO INDICATED TO INFORMANT APRIL TWENTY FOUR LAST THAT STONE PARK IS QUOTE A JUN MANSION END QUOTE, TOOK

AS THIRTY FIVE THOUSAND DOLLARS. CG SIX FOUR FIVE SEVEN DASH PC ADVISED THIS DATE THAT SHE RECALLED GIANCANA USED THE NAME OF MC DONALD ON OCCASION DURING STAY IN LAKE WORTH IN FIFTY EIGHT. SAID THAT SHE WAS ACQUAINTED WITH MC DONALD SLIGHTLY PRIOR TO HIS DEATH, AND DESCRIBED HIM AS A QUOTE COLLECTOR A END QUOTE FOR UNKNOWN INDIVIDUALS NAMED SEVERAL INSTANCES WHERE SHE OBSERVED HIM IN THE CAFE BOHEMIA, CHICAGO, CARRYING LARGE SATCHEL IDENTIFIED AS CONTAINING LARGE SUMS OF MONEY. STATED THAT SHE HAD NEVER HEARD OF A POSSIBLE OWNERSHIP OF LAKE WORTH PROPERTY ON PART OF MC DONALD. KEITH CAMPBELL, LIEUTENANT, CLARK COUNTY, NEVADA, SO, CURRENTLY IN CHICAGO FOR PURPOSE OF BACKGROUND INVESTIGATION OF JOE PIGNATELLO, MENTIONED PREVIOUSLY AS NOW BEING LAS VEGAS FOR PURPOSE OF BUYING INTO RESTAURANT. CAMPBELL INDICATED PURPOSE OF CONTACT WITH SGT. DUFFY, CHICAGO PD INTELLIGENCE UNIT, AND FORMER EMPLOYERS AND REFERENCES OF PIGNATELLO. STATED HE HAS NO PLANS AT PRESENT OF CONTACTING RICHARD B. OGILVIE, FORMER SAAG, RE THIS SITUATION, UNLESS HIS INVESTIGATION REVEALS NEED FOR SUCH A CONTACT. INVESTIGATION CONTINUING. ARMED AND DANGEROUS. (u)
