Legal Attache, London, advised police have obtained tape of Christine Keeler's recording which runs about 12 hours and a review of it to date has disclosed no new developments. This tape has been mentioned in newspaper articles as having been made by Keeler while under the influence of liquor and/or drugs and its exact contents are unknown. The tape allegedly had a bearing on the conviction of Keeler's former boy friend on a charge of assult.

ACTION:

There is attached a letter to the Attorney General 5 furnishing the information concerning the allegation about President Kennedy for his information. It is recommended this letter be delivered to the Attorney General by Assistant Director Evans.

2. There is attached a cable to the Legal Attaches, Madrid and London, requesting further information concerning the

allegations of espionage in Spain.
