Prior to this the nature of B&R Enterprises, Inc., was not known. However, it would appear that B & R Enterprises, Inc., was being used also for othertinvestments because the Lake Mead Marina was reportedly sold about a year ago to Mc Cullough Motors yet during the summer of 1962 money received from AL MATHIS, part owner of the Luau Restaurant in B.H. was deposited to one of ROTHMAN's accounts and thereafter money was paid out of this account to ROSSELLI in connection with some B & R Enterprises, Inc., transaction.

On 1-9-63 HARRY MC INTYRE, Sales Manager, Brand Motors, 2691 Crenshaw Boulevard, Los Angeles, advised that ROSSELLI purchased a 1963 Ford T-Bird from this firm on 12-6-62 for \$4350 which represents a discount of about \$1000 from the regular retail price. MC INTYRE said he did not know ROSSELLI before he wrote this sale and does not recall who told him to give ROSSELLI the discount but said it would have to be either JOHN BEBER or MITCHELL COOPER who are both owners of the firm.
