PETRINO then agreed to the telephone call and he said to LUBIN, "Tell JOHNNY I couldn't get in any way..... I don't like them looking to grab me...it isn't nobody... coppers are on me...I don't want this guy to get heated up". LUBIN then picked up his telephone and asked for the number of the Friar's Club, dialed the number that was apparently given to him, and asked for JOHN ROSSELLI. ROSSELLI was not there and LUBIN declined to leave a message, and said he would call back later.

On 6/1/64, the same source furnished information, as a result of a conversation between LUBIN and HAROLD MELTZER, that there are twenty guys "out here" that owe Chicago money and there are people out here from Chicago to collect from these guys. The possibility exists that the PETRINO conversation with LUBIN pertains to the information concerning the people who owe money to Chicago.

The Las Vegas Office advised that ROSSELLI checked into the Desert Inn Hotel, possibly on 5/26/64. Information has been previously furnished to the Bureau that ROSSELLI allegedly left Los Angeles for Las Vegas on 5/28/64.

LV:610-C advised on 6/3/64, that ROSSELLI was still at the Desert Inn Hotel, and was occupying this room with an unknown female (believed to be KATHY HORDEN).
