He stated arrangements had been made with a rancher in Broward County, Florida, to use his isolated farm as a training camp. The CCC further claimed it had full endorsement of ALLEN DULLES and the CIA.

BUCHANAN advised that in view of the publication of the story in the "Miami Herald" he intended to release his story along the same lines in the "Hollywood Sun-Tattler" on January 12, 1961.

MM T-1 has been involved in Cuban Revolutionary activities for the past three years, is a close associate of FRANK FIORINI and is in periodic contact with PEDRO LUIS DIAZ LANZ. (S)(u)

MM T-1 said on January 11, 1961, that FRANK FIORINI is presently co-operating and associating with VICTOR PANEQUE and ORLANDO BOSCH, leaders of the Movimiento Insurreccional de Recuperacion Revolucionario, an anti-CASTRO organization, which has established a training camp in Florida and anticipates a military expedition on the Cuban Government in the near future.

MM T-1 stated that PEDRO LUIS DIAZ LANZ is presently a member of the Frente Revolucionario Democratico (FRD) and is preparing to fly to Central America where he plans to make speeches and rallies aimed against communism and the CASTRO Government of Cuba.

MM T-1 explained that PEDRO LUIS DIAZ LANZ, former head of the CCC, was associated with FRANK FIORINI, and the CCC existed until about July, 1960, when LANZ discontinued CCC and formed the ALIANZA DE LIBERACION, which organization never got going and was thereafter discontinued. Thereafter, DIAZ LANZ joined the FRD; is still in that organization and has no plans to leave the FRD.
