On 1/30/61, Mr. [WILLIAM TIDWELL] CIA, Miami,  
Fla., advised that CIA now has an operational interest  
in both CONTE AGUERO and PEDRO LUIS DIAZ LANZ. On the  
same date, he said he would check to see if the CIA's  
interest extended to the Christian Anti-Communist Front,  
headed by CONTE AGUERO.

CIA HAS NO CONNECTION TO  
DECLASSIFICATION AUTHORITY  
RELEASE OF CIA INFORMATION  
IN THIS DOCUMENT, EXCEPT  
BY OADR

On 2/7/61, Mr. [TIDWELL] advised that CIA does not  
presently have an operational interest in the Christian  
Anti-Communist Front. He pointed out, however, that it is  
possible that CIA might acquire an interest in this organization  
at sometime in the future due to the changing nature of  
Anti-CASTRO activities.
