(JFK) ReBulet 12/16/60 to Newark, with copies to Miami, New York and WFO, entitled "CHRISTIAN ANTICOMMUNIST FRONT, IS - CUBA, REGISTRATION ACT - CUBA."

This letter pointed out that the Bureau is utilizing the English name as above entitled for the organization headed by LUIS ERNESTO CONTE AGUERO, of which case New York is origin.

Bureau letter also stated that the Spanish version of this name, Frente Anticomunista Cristiano, is being utilized for the organization headed by RICARDO JIMENEZ NUNEZ, of which case Miami is origin. This case is in a closed status.

New York letter dated January 17, 1961, in the case entitled "FRENTE ANTICOMUNISTA CRISTIANO, IS - CUBA," furnished file number as 105-2053; the New York airtel dated February 2, 1961, to the Bureau in the case entitled "LUIS ERNESTO CONTE AGUERO, IS - CUBA" designated an extra copy for Miami for 105-2053 on the Frente Anticomunista Cristiano organization, although airtel related to the Christian Anticommunist Front, according to the criteria prescribed by the Bureau.
