This is to secure authority for expenditure of up to \$150 to pay air fare, meals and lodging for Susan Frank, leading domestic pro-Chicom who has international connections, so she may travel to Chicago early in 1969 to confer with [ANC] informants and to address a forum of [ANC] members and contacts. [ANC is FBI intelligence operation staffed by Bureau informants and projected as true pro-Chicom group with objective of penetrating Chicom intelligence and political activities.] (S)

Frank, of New York City, a former Communist Party member has been closely associated with the leadership of the militant pro-Chicom Progressive Labor Party. She resided in Communist China during 1959-61 and has since been in contact with influential pro-Chicom abroad. She has been under intensified investigation by the New York Office based upon allegations she is a possible intelligence agent. When contacted by [ANC] informants on 10/28/68, Frank indicated a willingness to travel to Chicago to address [an ANC] sponsored group. (S)

This affords us an excellent opportunity to determine Frank's Chicom connections and to possibly develop intelligence while expanding the scope and potential of the [ANC] operation. Chicago Office, through [ANC] informants and contacts, can arrange a forum for Frank to address. An effort will also be made to have her address a [closed ANC] meeting and to reside during her visit at the residence [of ANC] informants. Informants will utilize opportunities to impress Frank with [the legitimacy of the ANC] to elicit intelligence information from her, and to assimilate [other ANC] contacts [into this operation] while at the same time cultivating local pro-Chicom who will be invited to the forum. (S)

ACTION:

That attached letter be sent Chicago authorizing [ANC] informants to invite pro-Chicom Susan Frank to Chicago to address [an ANC] sponsored group at a cost of up to \$150. (S)
