This letter is being submitted primarily for justification of the continued use of LA 4415C.

LA 4414C* was activated on July 17, 1962, per Bureau authority and deactivated on October 11, 1962, for security reasons.

LA 4414C* was employed at Doheny Towers, a fourteen story luxury apartment in West Hollywood, California, and furnished information regarding ALLEN SMILEY, his associates and their acquaintances.

DOHENY TOWERS offers hotel type service to its tenants and is highly patrolled by its employees. Any visitors in this apartment house are asked whom they wish to see and the tenant is telephonically advised of the caller and his identity.

SMILEY has obtained an apartment in ^{CALIF} this apartment house for a friend of his, named DALTON SMITH. SMILEY has given a key to his apartment to JIM ^{CALIF} HUSTON.

Los Angeles in order to afford full security believes LA 4414C* should only be reactivated at night preferably in the early morning hours.

SMILEY prior to October, 1962, was periodically leaving town for short visits, since October, 1962, he has not left town. He seldom leaves his apartment and seems to be conducting most of his business in his apartment.

LA 4415C is in a position to advise the Los Angeles Office when SMILEY is leaving and it is believed
