Source furnished no information except domestic affairs of ROCCO SCAFIDI, other than the fact that he was visited by an unknown male, apparently a relative of his.

9/29/64

ROCCO SCAFIDI made an outgoing call to "J.R." (SA J. ROBERT PEARCE). He advised that he had been around to sign some insurance papers; had visited 8th Street and observed nobody; and had talked to his brother SAM for awhile. TONY COPPOLA, SCAFIDI's employer, lost money at a crap game the previous Sunday. CHICKIE NARDUCCI won at the game. He talked of an address on Passyunk Avenue, Philadelphia (address of JACK WILLIAMS, aka) and said "there is a rumor going around that they are pushing ANGE (BRUNO) to get PHIL (TESTA) out and that everybody is asking ANGE is he sure PHIL is getting out."

It is noted that during the conversation source was asked where he was calling from, and he advised he was calling from his home but that no one was present. He was telephonically instructed not to use his home phone to contact the FBI Office. On 9/30/64, in person, he was again strongly reminded not to use his telephone to contact the Agents. He was reminded that his wife should not have knowledge of his activity. He said that she did not know of his activities. He said she thinks "J.R." is a brother of his employer, TONY COPPOLA.
