A review of the NY file of MICKEY DE MINO (NY 92-2557) reflected no brother or relative who could be identified with any of the above-listed members. In addition, NY 4609-PC advised that he is acquainted with underworld figures who are active in the New Rochelle area and MICKEY "The Leech" DE MINO is not known to him.

It is noted, however, that the agent to whom the DE MINO case is assigned is presently on special assignment in Jackson, Mississippi.

The possibility still remains that NK 2461-C4, in referring to the "GAMINOS" meant "DE MINO". Additional investigation will be conducted in this matter and other possible related associates in an attempt to resolve the true identities of the "GAMINOS".
