ON AUGUST 13, 1965, CIA, MIAMI, FURNISHED A MEMO

DATED AUGUST 11 PREDICATED UPON INFORMATION FROM AN UNIDENTIFIED
 LAW ENFORCEMENT OFFICER, REPORTING THAT ON AUGUST 10, ORLANDO
 BOSCH AVILA, HEAD OF MIRR, WAS ENGAGED IN MAKING PLANS TO
 SINK AN UNIDENTIFIED MERCHANT VESSEL DUE TO ARRIVE JACKSONVILLE,
 FLA., ON AUGUST 24 OR 25. A FROGMAN IS TO ATTACH A LIMPET
 MINE TO THE VESSEL. (S)(C)(U)

CIA ALSO REPORTED THAT AUGUSTO VALDES MIRANDA, AKA
 POLO, IS BELIEVED TO BE INVOLVED BY PERMITTING BOSCH TO USE
 HIS BOAT, WHICH CARRIES REGISTRATION FL-8477-F. CIA ADVISED
 AUGUST 16 IT HAS NO INTEREST AND POSSESSES NO ADDITIONAL
 PERTINENT INFORMATION. (S)(C)(U)

PREVIOUS INVESTIGATION BY THIS OFFICE REFLECTS THAT
 MIRANDA'S BOAT, FL-8477-F, IS NOW IN POSSESSION OF AND UNDER
 CONTROL OF CARLOS ZARRAGA MARTINEZ, KEY SOURCE-CUBAN, WHO
 DETESTS BOSCH AND HAS STATED HE WILL NOT COOPERATE WITH BOSCH
 UNDER ANY CIRCUMSTANCES NOR ALLOW HIM TO USE THIS BOAT

EXPLOSIVES EXPERT OF MIRR, DISCLOSED THAT HE HAS AN URGENT NEED FOR TWO "LAPICEROS," WITH A TIME DELAY ACTION OF 11 HOURS AND 50 MINUTES. A "LAPICERO" IS THE CUBAN TERM FOR A TIME DELAY DEVICE RESEMBLING A PENCIL WHICH IS USED TO SET OFF A DETONATOR FOR DEMOLITION PURPOSES. MIMO DID NOT REVEAL REASON FOR WANTING THIS ITEM.

MM 635-S HAS ALSO RECENTLY LEARNED THAT BOSCH POSSESSES A 57 MM. RECOILLESS RIFLE, A SMALL QUANTITY OF SHELLS FOR SAME, AND IS NOW SEEKING TO OBTAIN MORE SHELLS. PREVIOUS INVESTIGATION REFLECTS THAT THIS TYPE WEAPON IS FREQUENTLY DESIRED BY CUBAN REVOLUTIONARY GROUPS FOR USE ON SMALL ATTACK BOATS.

RE TAMPA AIRTEL, AUGUST 11, LAST, ADVISING THAT BOSCH PLANNED VISIT TAMPA, AUGUST 12-14 TO ATTEND A PUBLIC MEETING. IT WAS PLANNED TO SHOW MOVIES OF THE ATTEMPTED SABOTAGE OF A CUBAN VESSEL "ARECELIO IGLESIAS" NEAR PANAMA BY THE MIRR.

ON JULY 26 LAST, MM 974-S REPORTED THAT BOSCH WAS CONSIDERING MOVING HIS OPERATIONS TO TAMPA TO AVOID INVESTIGATION OF US GOVERNMENT AGENCIES IN MIAMI.

BOSCH HAS RECENTLY DISCLOSED TO MM635-S THAT HE IS PLANNING ANOTHER ACTION AGAINST CUBA BUT HAS FURNISHED NO DETAILS.

ON AUGUST 16, STANLEY SCHACHTER, US CUSTOMS, MIAMI, ADVISED THAT CUSTOMS IS ACTIVELY INVESTIGATING THIS MATTER.

JACKSONVILLE AT JACKSONVILLE IS REQUESTED TO ALERT LOGICAL INFORMANTS AND APPROPRIATE LAW ENFORCEMENT OFFICIALS
