The following investigation was conducted by SA MICHAEL D. MC NAMARA on September 30, 1965, at Brinkley, Arkansas:

MELVIN HAYES advised that he is currently residing at the Malham Hotel, Brinkley, Arkansas, and is employed as a crop duster pilot by the Tri-County Applicators Company, who fly and operate out of the airport at Brinkley, Arkansas.

HAYES advised that he knows Dr. ORLANDO BOSCH AVILA, and he is acquainted with the MIRR movement. He stated that he had been employed by BOSCH in the past and he might possibly be employed by him in the future. He stated that his previous employment by BOSCH did not result in the violation of any laws.

HAYES further advised that since the Spring of 1965, he has been furnishing information on a confidential basis and assisting a Mr. STANLEY SCHACTER of the U.S. Customs Service, Miami, Florida, in matters pertaining to customs violations. HAYES requested that prior to furnishing the FBI information concerning BOSCH or the MIRR, he would like to discuss the matter with SCHACTER.
