BOSCH has revealed to confidants that time delay devices were used in each of these instances.

BOSCH's Cuban Power should be distinguished from another Cuban Power group which operates under the leadership of HECTOR CORNILLOT LLANO and JUAN GARCIA CARDENAS, Cuban exiles.

CURRENT DEVELOPMENTS

A. BOMBINGS

1. MOST RECENT CLAIM

On August 4, 1968, MM T-1, a Cuban exile who is closely acquainted with members of BOSCH's organization as well as other groups, reported that on the night of August 3, 1968, ANDRES JORGE GONZALEZ GONZALEZ, described as the principal MIRR bomb expert, disclosed that he and BOSCH were expecting a big bomb to go off between August 5, and August 7, 1968, and sink a ship. GONZALEZ described the boat as being a small British ship with a Negro crew, but he did not specifically identify the ship nor divulge the time or place where the bomb had been planted. MM T-1 speculated that the bomb may have been placed in Miami on an island freighter plying between the Bahamas and Miami, as many of these vessels fly the British flag and have Negro crews. Also MM T-1 had seen GONZALEZ in Miami on August 2, 1968. (X)(u)

BOSCH, who was present, stated that after news of this bombing is made public, a press release will be issued by "ERNESTO, General Delegate, Cuban Power" announcing the appointment of BOSCH as the civilian delegate of Cuban Power. Previous investigation has reflected (X)(u)
