A confidential source who has furnished reliable information in the past, attribed on 10/14/70 that HANK GREENSPUN (ph) who was from Las Vegas had been in contact with General ELIAHU ZEIRA, Defense and Armed Forces Attache Embassy of Israel, Washington, D.C. (WDC)

The "Diplomatic List" published by the U.S. Department of State in November, 1970, confirms the above-described position of General ZEIRA.

GREENSPUN advised General ZEIRA that he had been in contact with one (AI SNAPPER who had recently been in Israel (S) discussing wood replacements, such as plastic (SNAPPER was 5) known as a 20th Century Edison because many of his designs (S) had been used in the American Spy Satellite System.

SNAPPER had proposed the development of a color coded (5) missile warning system for use in the United States manufactured (5) thantom jets as a replacement for the existing ("dot-dash" (5) warning system. The proposed system would signal the pilot (5) in blue regarding a missile which had just taken off, in (5) white for a missile that was on target and in red for the (5) danger zone.

GREENSPUN and ZEIRA agreed that the "dot-dash" (S) (warning system) was confusing to pilots) when many (missiles) were (S) fired simultaneously) (S)

GREENSPUN claimed that the new system would not be confusing in that the pilot could immediately take evasive action when the red signal showed. He noted that it was setimated to take \$100,000 to project the system but that he would have no problem raising the money, if in ZIERA's judgement the system was practical

ZEIRA noted that such a decision must be made in S Israel (S) GREENSPUN agreed to provide a short proposal in S writing while (ZEIRA) made appropriate checks regarding (SNAPPER.)

The system was to be provided to the Government of SI Israel, if they desired it, at no cost to them.
